LICENSE INFORMATION

- 1. Pursuant to Chapter 5, Article 3, Section 5-303, as amended, occupation licenses and fees are required for all businesses in the City of Westwood, Kansas.
- Information provided on this application may be forwarded to the Kansas Department of Revenue for purpose of verifying compliance with the provisions of the Kansas Retailers Sales Tax Act, K.S.A. 79-3601 et seq., as amended. Such information shall be subject to the confidentiality provisions set forth in K.S.A. 79-3614.
- 3. An additional annual fee applies to Massage Therapy Establishments per Chapter 5, Article 4 of the Westwood City Code. Please contact the City Clerk at (913) 362-1550 for further information.
- 4. Annual occupation licenses expire on January 15th of each year. Businesses that begin operation on or after July 1st of any year are charged one-half of the annual fee.
- Any person operating what is commonly known as a leased department in a business establishment shall pay the fee applicable to the business conducted by the department per 5-107 of the Westwood City Code.
- 6. Applications and fees are due at the Office of the City Clerk, Westwood City Hall, 4700 Rainbow Boulevard, Westwood, KS 66205.
- 7. Add 10% penalty if paying after the close of the business day February 15th. Add an additional 10% penalty for each additional 30 days' delinquency.
