A MESSAGE FROM THE MAYOR

Friends and Neighbors,

Fall has certainly arrived in Westwood, and as the weather begins to change, that can bring with it more people staying inside, bundling up, and the beginning of perhaps more winter isolation from each other. However, we certainly try to find opportunities to be with each other as a community, from our Oktoberfest, trick-or-treating on our streets, our annual holiday tree lighting, and in-between, our celebration of Thanksgiving. In that spirit, with my message for our community this Fall, I would like to touch on how we can continue to be good neighbors to each other, and to give thanks for those that continue to work to make Westwood such a good and tight community.

By the time this newsletter is published, our City will have had a new round of elections for our City Council. Of course, I am honored to have the opportunity to continue to serve as your Mayor. I am very thankful—as our entire City should be—for those who have volunteered their time and efforts to run for Westwood City Council, Holly Wimer, Laura Steele, and Melinda Garcia. Of course, I offer my thanks as well to Jeff Harris, Jason Hannaman, and Andrew Buckman, our other members of the City Council. In recent years, putting oneself out there to volunteer for our cities has become more and more difficult, especially post-Covid and with the rising partisanship infecting local matters. I must be honest with you, that the last year has been difficult for me at times, especially with—more and more—public comment periods and social media channels being used to level accusations against me and other members of the Governing Body and the Planning Commission in regard to the nowapproved Karbank and feature park project.

On October 24, 2023, the Kansas Leadership Center published an article in its Journal/Civics Issue Magazine an article titled "Political anger driving candidates, voters in more local Kansas races" (https://klcjournal.com/political-anger-driving-candidates-voters-in-more-local-kansas-races/). The overriding theme of the article is the rising use of anger as a moti-

vating factor in running for office, the normalization of confrontation as the appropriate way of engaging with volunteers, and the disillusionment of elected officials with their volunteer service. I am thankful that, by and large, Westwood has avoided the heavy partisanship that pervades issues in other cities, and



I am also thankful for all of our residents and volunteers that have continued to serve our city, discussed and disagreed without being disagreeable, and accepted that all people of good faith can work together for our community.

I certainly understand that some of this division has come from the City's recent consideration and approval of the Karbank proposal at 50th and Rainbow, a project that would establish a new commercial development on the City's existing property (including vacant property) and allow the City to triple the size of its parkland in the City on the adjacent former Westwood View Elementary School site. The City has attempted to provide a tremendous amount of information on this project for our residents, and to maintain the high standards of transparency which they expect. Updates on this proposal have been provided in nearly every weekly Westwood Buzz email for the past several months. It has been included in our newsletter. Numerous updates have been shared on the City's Facebook page. Renderings have been on display in City Hall. The City has a webpage dedicated to information on the proposal, with updates as they have been received from Karbank (https://www.westwoodks.org/ home-page/page/new-feature-park-developmentconsideration).

Ultimately, in September and October of this year, the City's Planning Commission and City Council approved development plans and rezoning for the project. These steps were taken with significant input from the public and involved numerous meetings and public hearings. (Continued on Page 2)

In considering these issues, and in preparing to make decisions on these issues, the City Council and Planning Commission have been guided by long range planning and community engagement efforts, including a 2015 Urban Land Institute (ULI) Technical Assistance Panel Study, our 2017 Comprehensive Plan, a second 2021 ULI Technical Assistance Panel Study, and a 2022 City Facilities Assessment and Feasibility Analysis, all of which came with impressive public participation.

Those measures—and the input received on the Karbank and new feature park proposal specificallyreflected broad public support for increasing our City's green space and allowing development that would make the City's goals financially possible.

I understand that there are residents, particularly in adjacent cities, that would prefer not to see the City of Westwood improve and develop with this project. Their and your concerns and input were absolutely considered as well, and through the process plans were changed and improved to address many if not all of these worries. The City also accepted a "protest petition" requiring a supermajority vote of the City Council Sincerely, for approval, which was met.

We are now very excited to begin work with our residents on planning for our new and much larger city Mayor David E. Waters

park and to continue to further the City's goals of increasing green space, putting vacant properties to productive use, expanding our tax base so as to lessen the burden on our residents, and providing amenities desired by our residents. To that end, we are excited to announce the creation of a Park Planning Steering Committee which will help select a professional park design partner, solicit and provide input on the park features most desired by the community, and otherwise guide the fun work of visioning a much larger, safer, and usable City park. This steering committee is intended to be made up of residents representing all of Westwood. As Westwood furthers its commitment to being a Community for All Ages, we want to be intentional in seeking input that will enhance park experiences for children, teenagers, young adults, families, and seniors—we want this to be a park for everyone to be able to enjoy. Look for additional details on these opportunities in the Westwood Buzz or other City social media channels.

FEATURE PARK PLANNING COMMITTEE— CALL FOR INTEREST

A group of around 10 or 12 individuals is being recruited to aid the City in the following ways to plan and design the new park site set to be acquired by the City from USD 512 next year:

- Review a Request for Qualifications and scope of work for a park planning consultant to transform the community's vision for the park into an actual design;
- Provide input on mapping out a broader community engagement strategy to ensure anyone and everyone in the community has multiple opportunities to share their vision, hopes, and dreams for the park;
- Guide the park planning consultant's work over the next year; and
- Ultimately make a recommendation to the Planning Commission and City Council on the best design and amenities for the park.

The best candidates to serve on this park planning steering committee will:

• Be able to commit to one meeting a month for the

entire calendar year of 2024;

- Represent strategic audiences the park is intended to ultimately serve as highlighted in the Message from the Mayor in this month's newsletter; and
- Submit a statement of interest or cover letter/resume to Abby Schneweis, City Clerk, either electronically to abby.schneweis@westwoodks.org, or in-person at Westwood City Hall, 4700 Rainbow Blvd., by Sunday, November 26th.

The statement of interest should include the following information:

- Name, address, phone number, and email address;
- Reasons for interest in serving on the park steering committee; and
- Length of residence in Westwood and applicant's goals for the park.

Depending on the volume of interest, candidates may be invited to interview further with Mayor Waters, other members of the Planning Commission or City Council, and/or City staff.

- Rake leaves into as narrow a pile as possible.
- Avoid raking the leaf piles directly under low- hanging tree branches as the leaf collection equipment gets tangled in the low overhanging limbs. A minimum of 14 feet in height, from the ground to the lowest limb is needed to operate the equipment. If this condition is found to exist, your leaves will be left until the pile is moved to a location that is accessible.
- Rake just to the curb or edge of the sidewalk but not into the streets, gutters, or onto the sidewalk so as to not force pedestrians into the street.

Your feedback will help the City of Westwood, Unified Government of Wyandotte County and Kansas City, Kansas (UG), and the Mid-America Regional Council (MARC) make the roadway more comfortable for all users.

BACKGROUND

With the University of Kansas Medical Center/University of Kansas Health System (KUMC/UKHS) campus as its anchor, the three-mile stretch of Rainbow Boulevard from I-35 on the north to Shawnee Mission Parkway on the south is booming. Economic development and growth are expected to continue for the next decade. In response, Westwood, UG, and MARC are developing the *Rainbow Boulevard Complete Streets Traffic Plan* to enhance the corridor with safe and improved transportation options. The planning process began during summer of 2023 and will conclude by early 2024.
