## URBAN LAND INSTITUTE SET TO FOCUS ON WESTWOOD ON MAY 7TH

The City of Westwood has been chosen by the Kansas City Chapter of the Urban Land Institute (ULI) to provide assistance for future planning of the 5050 Rainbow property , Joe D. Dennis Park and the nearby Entercom property. A panel will provide their expertise in financial, real estate, design, land use and market feasibility. The panel will conduct a preliminary review to fully understand the issues before holding a one day work session at City Hall on May 7th.

The Technical Advisory Panel with ULI has been asked to address the following issues:

- Considering its proximity to the elementary school and the city's long term goal to increase school enrollment, what is the best and most innovative redevelopment options for 5050 Rainbow & the park property?
- What is the estimated fair market value (residential and commercial) for development of the two properties along Rainbow Blvd?
- What might be the estimated costs to rehabilitate the 5050 Rainbow building or tear it down?
- Estimated costs to update and expand the park including removal and/or rehabilitation of the 5050 building?
- What is the estimated fair market potential for redeveloping the 8-acre Entercom property into the different land uses?

After a long winter everyone wants to enjoy the fresh springtime air by leaving sunroofs and car windows open and car doors unlocked. The problem is when we leave wallets, purses, brief cases in plain view in an unsecured car they are susceptible to theft. In the past year the Westwood Police Department has tried to engage everyone to help cut down on auto burglaries. In 2014 working together we were able to drop auto burglaries 44% compared to the previous year.

Unfortunately, auto burglaries have started to trend back up - we've had six this year. We been fortunate to devel-

To provide for the safe movement of children to and from school when crossing public roadways and intersections by observing gaps in the traffic and leading the children across the roadway or intersection. Crossing Guards are not to engage in traffic direction or control. Job Scope:

op a person of interest in all six of our cases, but those investigations are ongoing and they take a great deal of time, effort and resources to pursue. We always feel for the victims who have to cancel credit cards, contact insurance companies, and change locks. In the end, even if we catch the bad guy, the victim's property and peace of mind have been violated - and all of it could be avoided with a few simple steps.
