#### A MESSAGE FROM THE MAYOR

Friends & Neighbors,

Westwood is the best community in which to raise children, retire comfortably and live peacefully with loved ones. Its future will be built on optimism, perseverance and success. In today's world there are plenty of reasons to be negative or have doubt, but not here. Here, we have all the reasons in the world to celebrate life and be happy.

As I began my new term in April, alongside two new council members; David Waters and Margaret Bowen, I once again felt humbled and privileged to serve the people of Westwood. Our culture begins with the recognition that we are 'servants'. We are here to serve, first and foremost.

Westwood is home and yet it has the same challenges that all cities in Johnson County are confronted with. Of the challenges we face, one of the most important is to craft a delicate balance between long-term diversified revenues and protecting our first-rate, walkable community. With the help of our Community Affairs committee, we will be organizing an effort to enhance communications and build a much more open and inviting relationship with residents, businesses and stakeholders. Please know, you are welcome to participate; this is your community.

Woodside Village Phase II: As many of you have heard, Phase II Woodside Village and the Woodside Club renovations are gearing up to begin. A team of consultants has been working with Tanner & White Development on a recommendation for a revision to the finance plan (including TIF & CID) for Phase II which is located south of 47th Place. These elements already exist in the current agreement. Post-recession valuations, originally estimated in 2011 are actually much higher and construction costs have increased considerably. We anticipate a public hearing in August, so watch for notices. We need to remember that we are already partners with Woodside Club and Woodside Village. One of many considerations which are continually addressed is whether the plan will ensure long term success of the Club and be of long term benefit to the city. To assist us

with these questions, the city works closely with a consulting team of development experts and lawyers who routinely work on these types of projects. The cost for these consultants continues to be paid for by the developers so that there are no out of pocket costs to the city.

Comprehensive Plan: Much work has been done with multiple public meetings, steering committee meetings, interviews and Council work sessions. There will be yet another Council work session and another installment of public input, please plan on attending. We want to hear from you. You can catch all the updates on the website at https://westwoodtomorrow.com/.

**Lulu's Coffee Shop:** Recently, the owner of Lulu's had a revised site plan approved which allows them to install a neighborhood coffee shop at the old house just West of Lulu's.

**Westwood Village:** Conroy's Public House is now open in at 4730 Rainbow Boulevard. Residents are already raving about the food.

Westwood View: SMSD purchased the Entercom property in May with the intent to construct a new Westwood View Elementary. However many items will impact those decisions, including the State's ever constant debate over the school funding formula. Whether or not the school will really be built is yet to be known, but your City's leadership works closely with the school board and its superintendent. Some people have inquired about utilizing the greenspace for community access, but at this point the District has made no such concession to the public. Discussions have been had regarding this and will continue.

Westwood Christian Church: The City is looking at possibilities of refinancing the note on the Church at 5050 Rainbow. Decisions about the Church building, possible lease activity and future utilization have been discussed at Master Planning sessions and will continue to be addressed during the Comprehensive Planning.

**47th Street Overlay District:** 1889 Pizza is now open! This along with Lulu's, Gus's Fried Chicken, Taco Republic and Joe's KC BBQ is making our City a "destination location".

# A 14% POPULATION INCREASE FOR WESTWOOD, CENSUS BUREAU REPORTS

All northeast Johnson County municipalities have larger population estimates since 2010

New population estimates released today from the Census Bureau reports that Westwood's 2015 population stands at 1,719 people. That's an increase of 213, or 14% over the town's 2010 population count of 1,506.

To produce population estimates for cities and towns, the Census Bureau first generates county population estimates using a component of population change method, which updates the latest census population using data on births, deaths, and domestic and international migration. This yields a county-level total of the population living in households. Next, updated housing unit estimates and rates of overall occupancy are used to distribute county household population into geographic areas within the county.

The population estimate for Westwood may reflect the fact that the 91 new residential units for the first phase of the Woodside Village development was permitted for construction in November of 2014, according to Westwood's Chief Administrative Officer, Fred Sherman.

The Census Bureau's estimated growth in population for Westwood may also be due to other demographic changes.

"Clearly, the demographic trends are reversing," stated Westwood Mayor John M. Yé. "A decade ago Westwood was struggling to retain residents long term."

Families were not staying in Westwood with Sprint's departure and move to Overland Park, and demographic studies conducted for the Shawnee Mission School District projected a decline of enrollment at Westwood View Elementary. Instead, student population at Westwood View has increased.

"Westwood is the place to be!" reports Mayor Yé. "Westwood is now a highly sought after area for families to drop stakes and stay long-term".

All of the municipalities located in northeast Johnson County reflect larger estimated populations since the last 2010 Census population count was taken. The Census

# VOTERS TO DECIDE ON PUBLIC SAFETY ISSUES NOVEMBER 8

Johnson County voters will be asked on November 8 to vote on a quartercent public safety sales tax to fund a new courthouse to address safety and security issues for victims, families, and jurors; accessibility challenges, and overcrowding due to the growing population.

The sales tax will sunset in ten years. It will also fund a coroner facility. Currently, the county pays to use a lab in Wyandotte County.

The current courthouse design makes it difficult to keep inmates separated from victims, jurors and

families. This leads to close contact between victims and their alleged perpetrator in hall-ways and courtrooms, and between jurors and inmates during trial and deliberation. Numerous remodels and renovations have been completed to try to address these issues in the 64-year old courthouse, built for a population of 63,000 and now serving 575,000.

A new courthouse is less expensive than renovation and expansion of the current courthouse due to the significant design changes needed to improve security and accessibility and plan for growth. Renovating and expanding the existing building will



cost approximately \$34 million more than a new courthouse. Over the next 20 years, operating and maintaining the current courthouse will cost an estimated \$155 million more than a new courthouse due to the aging building and its inefficiencies. *Continued on page 4*

A new coroner facility would provide an accredited location to evaluate evidence and prevent crosscontamination of evidence. It would ensure autopsies are done in a timely manner. Under state statute, cities in Johnson County would split 34% of the total sales tax revenue for needed resources.

The city of Westwood would receive approximately \$ 397,000 in revenue

over 10 years.

The public safety sales tax would add a quarter to a \$100 retail purchase.
