Friend and Neighbors

I hope that this finds all of you well and that you've had an excellent summer. As the new school year dawns and we approach the changing colors of the landscape, we remain confident that Westwood is the best place in Johnson County to live, work or play!

Your City staff and Council have been busy preparing for this fall. Good things continue to happen as we prosper in Westwood. Our primary focus has been and will remain on serving the residents, property owners and businesses. Protecting the residential, family and walkable neighborhood will help us continue to grow and prosper. Good things to keep an eye on...

Westwood View Elementary: WWV has grown while at the same time reducing transfer students. This is a direct result of new families moving into are area while renovating and improving the housing stock. If you are a recent addition to Westwood, welcome! With upcoming elections and changes to the school district board, Council President Jason Hannaman has done a stellar job of keeping up the relationships between the school, the district and Westwood. We anticipate continued planning for a new Westwood View in the near future. Entercom Tower: As most of you know, the district purchased the Entercom property in 2016. They have already begun to remove the large tower in the center of the Entercom property. This represents a major change to the landscape in Westwood.

Council Replacement: Council member Margaret Bowen resigned her council seat in June. After careful consideration, the Council agreed that former Council President Paul Day would be best suited to fulfil Margaret's term. Paul served eight years on the Council and with him came a wealth of knowledge and experience and just in time for budget planning. Please welcome Paul back as he once again offers to serve the community with great outcomes.

**2018 Budget:** The Council worked diligently through the summer to put together the budget which has been submitted to the County. You will be happy to know that we were able to improve the compensation for the staff and fund our expenses which will include a new full time police officer with no increase in the mill rate. We

have spent years working collaboratively to diversify revenues. The increase in revenues provides the flexibility to service future debt the City may need to complete infrastructure improvements which are long overdue. Storm water improvements and aging infrastructure were outlined during the drafting of the comprehensive plan as priorities. The City will engage a municipal advisor soon to analyze this possible path.

Summer Events & Tennis Court: Summer has been filled with fun activities for our residents and neighboring areas. The July 4th fireworks display, movies in the park and a recently resurfaced tennis court at Dennis Park are part of what makes our community so great (Please help keep the kids' bikes and skate boards off the new court).

Community Connectors: With Council member Lisa Cummins' leadership, we will be creating a unit known as Westwood Community Connectors. This effort will build a team of volunteers that serve as liaisons between the residents and City Hall. We want more transparency and more connectivity. Woodside Village: The residential units in Phase I of Woodside Village are now fully occupied. # 2017 WESTWOOD FOUNDATION SCHOLARSHIP AWARDEE ANNOUNCED

During its June meeting, the Board of Directors awarded the \$5,000 per academic year scholarship to Yashi Wang. Yashi is a 2017 graduate of Shawnee Mission East and the daughter of Huizhen Wang and Zhiying Zhang. Among her many academic accomplishments Yashi earned a perfect score on the ACT, and is a National Merit finalist and scholarship winner, and a Kansas Governor's Scholar. Yashi is a member of the National Honor Society, Student Council, Parent Teach Student Association, Junior Classical League, Symphony and Chamber orchestras, and was a member and editor of the school newspaper and literary and art magazine. # WESTWOOD'S DAY-TIME POPULATION GROWS 250+ ON A GIVEN WORKDAY

The Census Bureau reports that Westwood's daytime population is 250+ greater than the city's residential population estimate, based on the FY 2014 Longitudinal

Employer-Household Dynamics (LEHD) data for the City of Westwood, Kansas.

About 938 individuals commute into the City of Westwood to work from other areas in the region. Approximately 686 Westwood residents work outside the city, and only about 17 or so individuals both live and work in Westwood.

The Census Bureau reports that Westwood's estimated July 1, 2016 residential population stands at 1,658 people. Base on the LEHD data, more than half, or about 56% of the town's resi-

dential population total commute into Westwood on a given work day.

With Midwest Transplant Network, the University Of Kansas Hospital Authority Cancer Center, and other corporate businesses located in the City of Westwood, workers commute from throughout the region to work in the city. Over 15% of individuals working in Westwood reported having to travel more than 50 miles to

work, while just over 50% of workers live within 10 miles of the city.


Most Westwood residents work outside the city. Westwood residents tend to work in many of the prominent employment center areas of the metropolitan region, like

> at the KU Medical Campus in Kansas City, Kansas; Downtown KCMO; the Crown Center and Country Club Plaza areas; as well as the College Boulevard area in Overland Park, Kansas. Virtually all Westwood residents commute less than 25 miles to work.

> The Longitudinal Employer-Household Dynamics (LEHD) program is part of the Center for Economic Studies at the U.S. Census Bureau. Under the LED Partnership, states agree to share Unemployment Insurance earnings data and the Quarterly Census of Employment and Wages

(QCEW) data with the Census Bureau. The LEHD program combines these data sets, additional administrative data and data from censuses and surveys.
