## **ORDINANCE NO. 995**

## AN ORDINANCE PROVIDING FOR THE COMPENSATION OF CITY OFFICERS AND REPEALING ALL PROVISIONS OR PRIOR ORDINANCES INCONSISTENT HEREWITH.

WHEREAS, Charter Ordinance No. 9 of the City of Westwood, Kansas provides that the Mayor with the consent of the Council, may appoint city officers including a municipal judge of the municipal court, a city clerk, a city treasurer, a city attorney, a chief of police, and such other officers as deemed necessary;

WHEREAS, Charter Ordinance No. 9 additionally provides that the pay of the various officers shall be regulated by ordinance;

WHEREAS, K.S.A. § 15-204 provides that the Mayor, with the consent of the Council, may appoint city officers including a municipal judge of the municipal court, a clerk, a treasurer, a marshal-chief of police, law enforcement officers and such other officers as deemed necessary;

WHEREAS, K.S.A. § 15-204 additionally provides that the pay of the various officers shall be regulated by ordinance;

WHEREAS, the Mayor, with the consent of the Council has utilized the enabling authority within Charter Ordinance No. 9 and K.S.A. § 15-204 to appoint the following public officers: municipal judge of the municipal court, city clerk, city treasurer, city attorney and chief of police;

WHEREAS, pursuant to Charter Ordinance No. 9 and K.S.A. § 15-204, the City Council adopts the present ordinance to establish the pay of the appointed officers of the City.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WESTWOOD, KANSAS:

**Section One.** The following pay established for the following non-elected, appointed officers of the City who are not employed in a full-time capacity with the City:

Officer	Monthly Pay
City Treasurer	\$900
Municipal Judge	\$900
City Attorney	By contract

**Section Two.** Compensation for the full-time officer positions of City Clerk and Chief of Police shall be established by the Mayor. Prior to making any changes to the

Compensation of the City Clerk or the Chief of Police, the Mayor shall consult with the Administration and Compensation Committee relating to the intended change in Compensation. For purposes of this section, the term "Compensation" shall include employee rates of pay, salary, pay rate ranges and salary ranges. "Compensation" shall have the same meaning as the term "pay" as that term is used within Charter Ordinance No. 9 and K.S.A. § 15- 204.

**Section Three.** This ordinance shall take effect and be in force from and after its adoption and publication as required by law.

**Section Four.** All provisions or prior ordinances inconsistent herewith are hereby repealed including, but not limited to, Ordinance #968.
